SUBJECT: APPROVE A SECOND AMENDMENT FOR PROCUREMENT CONTRACT NO. 14973 WITH FAMILY BUILDERS BY ADOPTION

RECOMMENDATIONS:

- A. Approve a Second Amendment to a contract (Procurement Contract No. 14973) with Family Builders by Adoption (Principal: Jill Jacobs, Location: Oakland) to provide adoption permanency services to the Alameda County Probation Department, extending the contract term of 5/15/17 5/14/19 by one year to 5/14/20, and increasing the contract amount from \$344,000 to \$532,942 (\$188,942 increase); and
- B. Authorize the Chief Probation Officer or designee to execute the amendment upon review and approval as to form by County Counsel.

DISCUSSION/SUMMARY/FINDING:

Family Builders by Adoption (FB) is a licensed adoption agency that brings 40 years of experience with a seamless continuum of foster-adoption services all provided with cultural and trauma responsiveness. FB has a long track record of excellence in permanency work with older youth in foster care and working closely with county staff and administrators to improve permanency practice. On May 9, 2017, Item No. 25, your Board approved a one-year contract with FB to provide adoption permanency services. On March 13, 2018, Item No. 43, your Board approved a First Amendment to extend the contract period for one year from 5/15/17-5/14/18 to 5/14/19 and increased the total contract amount from \$172,000 to \$344,000 (\$172,000 increase).

As a result of AB 403 Continuum of Care Reform, Probation Departments are required to discontinue use of level 1-10 group homes and instead use resource families for the care of foster youths. The goal of AB 403 is to ensure that foster youths are cared for in family-like

environments in hopes that they will receive better treatment and have healthier outcomes. The Core beliefs inherent in this family finding, assessment and preparation approach are:

- Every child has a family and they can be found if we try;
- Loneliness can be devastating, even dangerous and is experienced by most children who are in out of home care;
- A meaningful connection to family helps a child develop a sense of belonging; and
- The single factor most closely associated with positive outcomes for children is meaningful, lifelong connections to family.

This contract allows for this amendment by mutual agreement.

SELECTION CRITERIA/PROCESS:

On April 12, 2019 General Services Agency-Procurement issued a Finding of Piggyback Acceptance and approved Piggyback No. 4621-2 for a total contract amount of \$532,942 with an expiration date of May 14, 2020.

Family Builders by Adoption (Certified Small: 17-00020; Expiration: January 31, 2020) is a certified Small, Local & Emerging Business and has performed satisfactorily through the contract term.

FINANCING:

Funding for this contract is included in the ACPD Fiscal Year 2018-19 Approved Budget and will be requested in future budget years. No additional funding is required, and there will be no impact to net County cost as a result of approving the above recommendations.

VISION 2026 GOAL:

The adoption permanency services meet the 10X goal pathway of a <u>Crime Free County</u> in support of our shared vision of a <u>Thriving & Resilient Population</u> and <u>Safe & Livable Communities</u>.

SECOND AMENDMENT TO AGREEMENT

This Second Amendment to Agreement ("Second Amendment") is made by the County of Alameda ("County") and Family Builders by Adoption (Family Builders), ("Contractor") with respect to that certain agreement entered by them on May 15, 2017 (referred to herein as the "Agreement") pursuant to which Contractor provides Assessment/Permanency/ Acceptance/Training/LiveScan services to County.

For valuable consideration, the receipt and sufficiency of which are hereby acknowledged, County and Contractor agree to amend the Agreement in the following respects:

- 1. The term of the Agreement is currently scheduled to expire on May 14, 2019. As of the Effective Date, the term of the Agreement is extended through May 14, 2020.
- 2. Contractor shall provide child-specific youth permanency services to a caseload of 20 youth with a service delivery time of 6 -24th months beginning May 15, 2019.
- 3. Contractor shall provide the following services:
 - a. Contractor shall provide child-specific youth permanency services to a caseload of 20 youth with a service delivery time of 6 -24th months beginning May 15, 2019.
 - b. Conduct Resource Family Approval (RFA) psycho-social assessments on a feefor-service basis for 25 assessments per year beginning May 15, 2019 through May 14, 2020. Assessments will be completed within 90 days unless the family or department causes delay. Re-assessments will also be provided. Cost will be \$2,000 per assessment for a total of \$50,000.
 - c. Provide training that will include 12 hours of pre-approval training in accordance with the RFA Written Directives. This service will be billed at \$500.00 per applicant trained, on a fee-for-service basis for a total of \$12,500.

- d. Provide 25 individuals with CPR/ First Aid training at \$70 per individual for a total of \$1,750.
- e. Provide 25 individuals with livescan finger prints at \$94 per individual for a total of \$2,350.
- f. Contractor shall bill for salaries, program expenses, and operating expenses for a total of \$122,342
- g. Total maximum reimbursable total for this contract is \$188,942.
- 4. In consideration for Contractor's additional services, the County shall pay Contractor in an additional amount not to exceed one hundred eighty-eighty thousand nine hundred forty-two dollars (\$188,942). As a result of these additional services the not to exceed amount has increased from three hundred forty-four thousand dollars (\$344,000) to five hundred thirty-two thousand nine hundred forty-two dollars (\$532,942) over the term of the Agreement.
- 5. Except as otherwise stated in this Second Amendment, the terms and provisions of this Amendment will be effective as of the date this Second Amendment is executed by the County May 15, 2019.

6. DEBARMENT AND SUSPENSION CERTIFICATION:

- b. By signing this Second Amendment Contractor certifies to the best of its

knowledge and belief, that it and its principals:

- Are not presently debarred, suspended, proposed for debarment, declared ineligible, or voluntary excluded by any federal department or agency;
- (2) Shall not knowingly enter into any covered transaction with a person who is proposed for debarment under federal regulations, debarred, suspended, declared ineligible, or voluntarily excluded from participation in such transaction.

7. SMALL LOCAL AND EMERGING BUSINESS PARTICIPATION:

Participation of a small and/or emerging local business must be maintained for the term of this contract. Contractor shall not substitute the small and/or emerging local business(s) listed in this agreement without prior written approval from the County. County will be under no obligation to pay contractor for the percent committed to a small and/or local business if the work is not performed or not performed by the listed small and/or emerging local business.
