**SUBJECT:** Approval of Contract Funding Renewals for FY 2008-2009

**RECOMMENDATION:**

In order to continue providing contract services to the communities served by the Social Services Agency during FY 2008-2009, it is recommended that your Board:

- Approve Contract Funding Renewals for contracts listed on Attachment A, effective July 1, 2008, through June 30, 2009, with maximum amounts not to exceed levels shown, all to be executed under the Master Contract process, and delegate authority to the Social Services Agency Director, or designee, to execute the contracts.

**SUMMARY:**

This letter requests action by your Board to approve the annual listing of Community Based Organizations administered by the Social Services Agency (SSA), to be effective July 1, 2008, for which funding renewal is requested and for delegating authority to the Social Services Director, or designee, to execute contracts under the Master Contracting process. In addition, for many contracts, maximum levels are set forth which serve as a policy reference for the Auditor-Controller in encumbering contracts (as used in the Master Contract process).

**DISCUSSION:**

The attached list identifies SSA contracts to be effective July 1, 2008 for which approval of funding renewals is requested. This action is recommended by County Counsel to allow payment for contract services from July 1, 2008 when continuing contracts are finalized at a later time. Contracts with Community-Based Organizations, to be processed under the County's Master Contract process, are listed on Attachment A. Approving these contracts for funding renewals will permit encumbrance and payment for services effective July 1, 2008. This letter requests authority for the Agency Director, or designee, to approve contract exhibits. These contracts include a provision for reduction in funding levels or termination of agreements in the event revenues are less than anticipated in the proposed Agency budget and based on actual contract compliance.

**SELECTION CRITERIA AND PROCESS:**

*All of the agreements on the attachment have been approved by previous Board action. All were recommended according to the County's contracting policy. Some were awarded through an RFP/Q process; others were determined by the contractors' specialized skills and services. As these contracts are considered for renewal, each will be reviewed with emphasis on the County's policy to use County agencies, a competitive process and local vendors.*

**FINANCING:**

Financing for contracts on the attached list for your Board's approval will come from State, Federal and County General Funds included in the Social Services Agency proposed budget for FY 2008-09. This request will not require any additional appropriation of funds. There is no change to net County cost resulting from approval of funding renewals of these contracts.
