

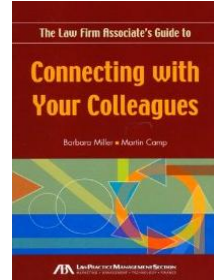
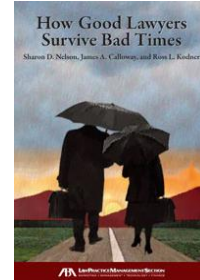
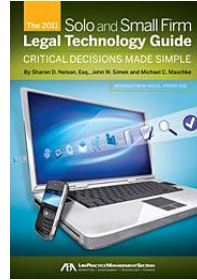
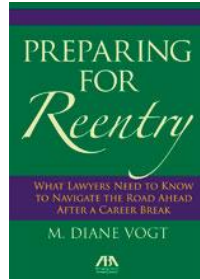
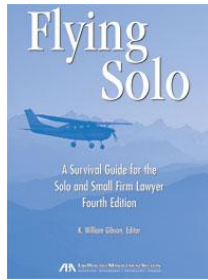
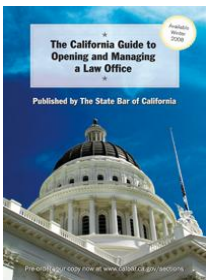
Law Practice Management and Professional Development Collection at The Alameda County Law Library
