- 1. We are working with Probation with regards to access as things have recently changed. The Deputy Chief is very responsive to my calls.
- 2. There is a meeting scheduled with Dr. Gerchow to discuss what is happening with the kids. Many of the kids who have come to us have had late diagnoses.

Probation

- 1. Positive Youth Development (PYD) updates **Dante Cercone**
 - a. There will be a positive futures fair on March 27 at Hayward High School from 3 pm to 7 pm. This is an opportunity for CBOs primarily from the DPM to show up as well as county, city, and education; the idea is to be a one-stop resource shop to inform the community about these free services for youth.
- 2. General Updates Yasmin Burke
 - a. The SB823 program had been called by the law identifier; the program has been renamed Firm Roots Academy.
 - b. Occupational Therapy began providing services on March 1. The youth have enthusiastically responded and are self-referring for services.
- 3. Demographics Juvenile Hall

Number of youths in Juvenile Hall -32; 25 are male and 7 are female.

- a. GPS 25 are male and 2 are female.
 - Education 4 are in High School and 9 are in college.

 - a. 227 encounters
 - b. 100 after-hours crises
 - c. 27 intakes

Social Services, Mia Buckner-Preston

- 1. In February 2024, there were 57 intakes in the Assessment Center (AC).
 - a. Most intakes were male and six large number sibling groups.
 - b. There were 3 overstays from the sibling group.
 - c. The average length of stay was 51 hours.
- 2. The Assessment Center is still in the process of moving to a new facility in Castro Valley.
 - a. The state is assessing both facilities to determine how much longer an extension is needed.
 - b. The current AC is still operating. The state has provided an extension through April 30.

Oakland Unified School District, Hattie Tate

Colleagues of Dr. Crawford are creating a scholarship for his son who is graduating from high school in May.
