RE: Update on the implementation of Cast Vote Record Reports

On May 16, 2024, the Elections Commission voted to recommend that the Alameda County Board of Supervisors direct the Registrar of Voters to follow San Francisco's Cast Vote Record (CVR) model and adopt a policy of releasing text CVR reports concurrent with election result update for the November 2024 election. The CVR committee has been following up to ensure that the issue is agendized before the Board of Supervisors and implemented before the November 5, 2024 election. There are a few remaining tasks.

The commission's recommendation will be heard by the Board of Supervisors' Personnel, Administration and Legislation (PAL) Committee (see description below) on August 5 and is tentatively scheduled for the September 17th Board of Supervisors meeting.

The CVR subcommittee would like to encourage all commissioners to speak in favor of CVR implementation at the board meeting.

The CVR subcommittee met with Supervisor Tam's office to discuss the commission's recommendation and is now working to schedule a meeting with staff from the office of Supervisor Elisa Marguez.

The Personnel, Administration and Legislation (PAL) Committee reviews federal, State and local legislation and other legislative and administrative matters referred by County departments, including Board offices, for support or opposition; reviews and signs all letters of support or opposition for legislative matters; reviews and recommends approval of the legislative platform and County priorities; advances all recommendations to the full Board of Supervisors for final approval; receives regular updates from State and federal legislative advocates on emerging legislative matters affecting local government; and provides direction to advocates on advancing the County's legislative agenda.

The PAL committee meets every Monday at 1:30 PM in the Board of Supervisors' conference room located at 1221 Oak Street, 5th Floor, Oakland. Supervisor Keith Carson, District 5, serves as the PAL Committee Chair.




