Summary/Action Minutes

I. Federal Legislative Update – CJ Lake

Congressional Schedule

The House is not in session through the General Election. The Senate will recess this evening after the vote on the confirmation of Amy Coney Barrett. Both chambers could be called back for a vote with 24 hours' notice.

Supreme Court

The Senate will vote on the confirmation of Amy Coney Barrett this evening. The vote is expected to pass. The Senate held a procedural vote on Saturday, which passed by a vote of 51-48 with Senators Lisa Murkowski and Susan Collins voting with Democrats in opposing moving forward. (Senator Harris did not vote).

COVID-19 Stimulus

Little progress was made in talks regarding a coronavirus relief package. It is unlikely that a stimulus bill will be written, voted on, and signed into law by President Trump before the election. Speaker Pelosi said she is waiting for another counter offer today from Treasury Secretary Steven Mnuchin, as she and White House Chief of Staff Mark Meadows accused each other of "moving the goalposts" in negotiations. Congressional committee staff spent much of the weekend writing relief legislation, but aides in both parties said little progress was made despite the pledges from both sides that they want to quickly deliver \$1,200 stimulus payments to most Americans along with aid to struggling businesses.

USDA Food Box Program

The U.S. Department of Agriculture announced last week that it has authorized \$500 million for a fourth round of purchases for the USDA Farmers to Families Food Box Program. USDA expects to award contracts by Oct. 30 for deliveries of food boxes from Nov. 1 through Dec. 31, 2020. USDA has so far purchased just under \$3 billion worth of food.

This program was created in response to significant workforce losses at restaurants, hotels and other food service businesses. USDA has partnered with national, regional and local distributors, to purchase fresh produce, dairy and meat products from American producers of all sizes.

The program supplies food boxes of fresh fruits and vegetables, dairy products, meat products and a combination box of fresh produce, dairy or meat products. Distributors package the products into family-size boxes, then transport them to

food banks, community and faith-based organizations, and other non-profits.
