# **Summary/Action Minutes**

# I. Federal Legislative Update – CJ Lake

#### **Schedule**

Both the House and Senate are in session this week with an expectation they will wrap up the FY23 omnibus appropriations bill by Friday. The Senate is in session today and the House is planning to come back on Wednesday and remain in until final passage.

#### **FY23 Appropriations**

On Thursday, the Senate passed a bill to fund federal agencies for one more week, averting a government shutdown. The stopgap bill, which extends funding through December 23<sup>rd</sup>, was approved by a 71-19 margin. The House passed the CR by a vote of 224-201, with just nine Republicans joining the Democrats to pass the legislation.

Congress has made significant progress on an omnibus spending bill over the last week. Leadership announced they reached an agreement on topline spending last Monday but haven't yet publicly released the numbers. Subcommittees received their allocations on Friday, an important step in the process of bill writing.

Appropriations subcommittees worked through the weekend, and the final bills could be unveiled as early as later today. The Senate will vote on the omnibus first, and hopefully they vote on final passage no later than Thursday. House leaders have alerted members that they will come back into session Wednesday. The chamber will stay in session until the omnibus package is passed. Given the current picture, it is likely that the House will vote on the bill on Friday.

## II. State Legislative Update – Political Solutions

Action at the Capitol is coming to a slow down. The Legislature held the desk open until Friday, December 16<sup>th</sup> which allowed Legislators to continue to introduce bills. The PS Team has been reviewing the introduced bill reports daily and has elevated bills of interest to County Staff.

### **Election Update**

California Secretary of State, Dr. Shirley Weber, certified the General Election results on Friday, December 16. Her office reports that of the 11,146,610 ballots cast, 1,391,422 (12.48%) ballots were cast in person and 9,755,188 (87.52%) voters cast a vote-by-mail ballot.
