Summary/Action Minutes

I. Federal Legislative Update - CJ Lake

Schedule

The Senate will be in session and the House is scheduled for a committee work period.

Budget & Appropriations

The current continuing resolution (CR) expires this Friday, February 18th. Last Tuesday, the House voted to advance another CR through March 11th. More than 50 Republicans joined the Democrats to pass the measure. Majority Leader Chuck Schumer says the Senate will vote on the CR this week, before Friday's deadline.

Key Congressional Democrat and Republican appropriators took an important step forward last week, agreeing on a "broad framework" for an omnibus spending bill. Subcommittee leaders received their topline spending figures last Friday, allowing work to get started on the 12 spending bills. It is expected Congress will be able to finalize an omnibus bill by March 11, 2022.

Passing a spending bill will be key for fully funding the bipartisan infrastructure bill that passed last year. The Congressional Budget Office estimates that \$197 billion from that \$550 billion law cannot be unlocked for use over the next 10 years unless annual appropriations bills are enacted.

Infrastructure Investment Jobs Act (IIJA) Implementation

Late last week, the U.S. Departments of Transportation and Energy announced nearly \$5 billion that will be made available under the new National Electric Vehicle Infrastructure (NEVI) Formula Program established by Infrastructure Investment and Jobs Act, to build out a national electric vehicle charging network. The program will provide funding over five years to help states create a network of EV charging stations along designated Alternative Fuel Corridors, particularly along the Interstate Highway System. The total amount available to states in Fiscal Year 2022 under the NEVI Formula Program is \$615 million.

States must submit an EV Infrastructure Deployment Plan before they can access these funds. The Department of Transportation reported that California will receive over \$56.7 million in 2022 and \$383.6 million over five years through this program. There is an 80-20 cost sharing component to this program. The Federal share payable for the cost of a project will be 80 percent and either the state or private funding sources will be responsible for the remaining 20 percent.

The Federal Highway Administration released the NEVI Formula Program funding to states that will be available following approval of state plans for Fiscal Year 2022 in addition to the Program Guidance and a Request for Nominations for states to expand their existing Alternative Fuel Corridors.

COVID-19 Update

The California Secretary of Health and Human Services, Dr. Mark Ghaly, provided an update on COVID-19 in California. Dr. Ghaly presented an outlining of the goal of California's Department of Public Health (CDPH) to understand current data trends, provide context for the state masking requirements, and preview an approach to keep schools open and thriving.

As of February 15th, CPDH will move to strongly recommend masks in public indoor settings while still requiring them in health care facilities, schools and childcare facilities, long-term care homes, and in jails and prisons, with the state allowing for local communities to build upon these requirements. Per Secretary Ghaly, as of today, the school masking requirements will not change; however, based on current data the state is getting close to being able to lift school requirements.
