# **Summary/Action Minutes**

# I. Federal Legislative Update – CJ Lake

Schedule

Both the House and the Senate are back in session this week, returning from their two week recess.

# **COVID-19** Supplemental

Just before the recess, the Senate was negotiating a deal over the \$10 billion Covid-19 supplemental spending bill. However, several Republicans and a handful of moderate Democrats demanded a vote on an amendment regarding Title 42, a pandemic-era policy that allowed officials to quickly expel migrants and asylum seekers at the border during a public health emergency. Leader Schumer has indicated that an amendment over Title 42 would be a poison pill for the package in the Senate and face significant trouble passing the House. As a result, the item had been shelved until they returned from recess. We are expecting this to be a priority as President Biden is expected to request additional funding to provide assistance to Ukraine and the two items may be brought together as a package.

As a reminder, the bill would provide \$10 billion for the Department of Health and Human Services, through the Public Health and Social Services Emergency Fund. This includes \$9.25 billion to develop and purchase vaccines, therapeutics, and other supplies. At least \$5 billion of that funding would go to therapeutics. And at least \$750 million of the funding would be set aside to develop vaccines for emerging Covid-19 variants. The bill does not include any global vaccination money.

The bill also does not include funding for the COVID-19 Uninsured Program, meaning providers will bear the costs of administering vaccines to patients who have no insurance coverage. Vaccines will continue to be made available through the federal government at no cost, but uninsured patients can be billed for COVID-19 tests and treatments such as antivirals and monoclonal antibodies at the discretion of providers.

The bill will also provide state, local, and tribal governments additional flexibility to spend federal pandemic relief funds, including on infrastructure and community development projects. The legislation will update eligibility to the American Rescue Plan's Coronavirus State and Local Fiscal Recovery Fund (SLFRF), with two specific changes to note.

• Adds an additional criterion for SLFRF dollars, "to provide emergency relief from natural disasters or the negative economic impacts of natural disasters, including temporary emergency housing, food assistance, financial assistance for lost wages, or other immediate needs."

- Authorizes state and local governments to use SLFRF funds for infrastructure projects including:
- Community Development Block Grant projects (CDBG)
- RAISE grant projects
- Nationally significant freight projects
- Nationally significant highway projects
- Bridge replacement/rehabilitation projects
- Surface transportation block grant projects
- Metropolitan transportation planning projects
- Highway safety improvement projects
- Congestion mitigation and air quality (CMAQ) projects
- Electric vehicle charging and hydrogen, propane, and natural gas fueling corridors
- Rural surface transportation grant program projects
- Carbon reduction program projects
- PROTECT grant projects
- Federal lands transportation program projects
- Federal lands access program projects
- Projects with TIFIA loans
- Urbanized area formula grant projects
- Fixed guideway capital investment grant projects
- Formula grant projects for rural areas
- State of good repair grant projects
- o Bus and bus facilities projects
- o National culvert removal, replacement, and restoration grant program projects

# **Big City Mayors Press Conference – Homelessness Response**

The conference included Oakland Mayor Libby Schaaf, San Diego Mayor Todd Gloria, San Jose Mayor Sam Liccardo, Fresno Mayor Jerry Dyer, Bakersfield Mayor Karen Goh, Stockton Mayor Kevin Lincoln, Riverside Mayor Patricia Lock Dawson, and Santa Ana Mayor Vicente Sarmiento.

In summary, the mayors are calling on the Governor to provide \$1 billion a year in HHAP flexible funding for 3 more years. Full notes from the press conference are attached.
