Schedule

The House and Senate are both in session this week and scheduled to be in Washington for legislative business for the next four weeks.

FY25 Appropriations

House and Senate Appropriations Committees released Fiscal Year 2025 appropriations guidance and deadlines last week. House members must submit their programmatic and language requests to subcommittees by this Wednesday evening and their community project funding requests by Friday. Senate deadlines are between May 8th and May 15th, depending on the subcommittee. Members have two weeks from the subcommittee deadline to post their submitted projects online, so potential recipients should know if their requests were included in the process near the end of May at the latest.

Other Must Pass Legislation

Senate and House negotiators released the FAA reauthorization bill. The first procedural vote in the Senate will likely occur on Wednesday. There have been several extensions of current funding, and Congress needs to act on the FAA bill by the May 10th expiration date.

The Farm Bill expired in September of 2023. House Agriculture Chairman Glen Thompson (R-PA) has stated his committee will mark up a bill prior to the Memorial Day recess. The Farm bill includes provisions related to SNAP, as well as agriculture. The Senate has not set a date for mark up and there will not likely be any movement on a Farm Bill until the next Congress.
