Summary/Action Minutes

I. Federal Legislative Update – CJ Lake

Schedule

Both chambers are in session this week and the week of May 15. The Senate will recess the week of May 22^{nd} leading up to Memorial Day.

Debt Limit Update

President Joe Biden is scheduled to meet Speaker Kevin McCarthy (R-CA) and other congressional leaders tomorrow to discuss the debt ceiling. President Biden and Republicans are locked in a stalemate over raising the \$31.4 trillion borrowing limit, and Republican leaders are demanding promises of future spending cuts before they approve a higher ceiling. President Biden has insisted on a "clean" increase, with budget cut talks kept separate. House Republicans have sought to increase leverage over President Biden by passing a plan that calls for an increase in the debt ceiling by \$1.5 trillion, which is enough to prevent a default until March 31, 2024, in exchange for \$4.8 trillion in budget cuts over the next ten years.

A group of 43 Senate Republicans including Minority Leader Mitch McConnell (R-KY) said they would oppose allowing a vote on legislation increasing the debt limit with no strings attached, saying "substantive spending and budget reforms" must be part of the package. Democrats have said they will negotiate with Republicans on some budget limits, but that it is "hostage-taking" to tie spending cuts to a boost in the debt limit. According to estimates from Treasury Secretary Janet Yellen, Congress and the White House have just 24 days, including weekends, to finalize a deal on the debt limit.

House Immigration Bill

The House is scheduled to vote this week on H.R. 2, the Secure the Border Act of 2023. The legislation would require the Biden Administration to restart construction of the border wall, increase the number of border patrol agents, and expand collection of DNA and biometric information at the border and impose fees for asylum applicants, among other things. The bill will go to the Rules Committee tomorrow with a full vote on the House floor expected on Thursday when Title 42 is set to expire.

Republicans are using the legislative effort to try to make good on campaign promises to tighten border enforcement, with migrant encounters hitting records during much of President Joe Biden's tenure so far. Any House-passed border legislation is likely to come to a standstill in the Senate, though narrower provisions could serve as a starting point for future immigration negotiations.

Title 42 is set to expire on Thursday, May 11th, when the Public Health Emergency related to covid is lifted. Title 42 was created to address public health and social welfare and grants the government the ability to take emergency action in numerous ways, including to "stop the introduction of communicable diseases." This policy was used widely beginning in March 2020 to regulate border crossings under the premise of increased COVID-19 precautions.

II. State Legislative Update – Political Solutions

The Senate and Assembly Appropriations Committee will work their way through remaining bills over the next two weeks and will then hold their Suspense File hearing. The Committee deadline is Friday, May 19th, which all bills with a fiscal tag must be heard if they are to move this year. Of importance, the County's sponsored/co-sponsored bills AB 922 (Wicks), AB 1313 (Ortega) and AB 1387 (Ting) will be taken up in Assembly Appropriations on Wednesday, May 10, 2023.

Early Action Budget Bill Package

The Legislature passed an early action budget package on Thursday, May 4. The bills, which are copied below, are still pending signature on the Governor's desk.

- AB 100 Ting Budget Acts of 2021 and 2022. Technical fixes to 2022 expenditures
- AB 110 Committee on Budget Early Childcare and Education. Authorizes California Department of Education and Department of Social Services to provide temporary stipends/ Additionally waves family fees through September 2023.
- AB 111 Committee on Budget Personal Income Tax Law: Exclusion: Student Loan Debt. Ensure pandemic relief and loan forgiveness for college students is not considered income for purposes of state income taxes.
- AB 112 Committee on Budget Distressed Hospital Loan Program. Hardship relief to struggling hospitals
- AB 113 Committee on Budget Agricultural Labor Relations. Finalizes crucial details for farm worker relief.

- AB 922 (Wicks) Prepared Meals Delivery Program. Status: Set for hearing in Assembly Appropriations for May 10.
- AB 1313 (Ortega) Older individuals: case management and visitation services Status: Set for hearing in Assembly Appropriations for May 10.
