Summary Action Minutes

I. General Services Agency - Outreach, Contracting and Procurement Report Attachment

Detra Dillon, General Services Agency, presented the General Services Agency - Outreach, Contracting and Procurement Report.

This report covers the period of October 1, 2022, through December 31, 2022.

Goods and Services Contracts (inclusive of Professional services)

During the current reporting period, the General Services Agency conducted 11 formal bid processes that resulted in 16 contracts totaling \$17,649, 938.

Contracts by SLEB/Local/Non Local

- SLEBs: 5 contracts totaling \$6,858,437
- Local (non-certified): 4 contracts totaling \$1,464,373
- Non-local: 7 contracts totaling \$9,327,129

Architecture and Engineering Contracts/Design/Build Contracts

There were no contracts awarded for this reporting period.

Construction Contracts

There were five (7) awarded contracts for this reporting period, in the amount of \$1,450,100.

- Santa Rita Jail Housing Unit Security Screen Installation Crusader Fence Company, LLC (Non-Local): \$390,148
- Emergency Transformer Replacement, Foothill Blvd. San Leandro PB Electric, Inc. (Non-Local): \$400,000

II. Auditor-Controller Agency Procurement Quarterly Report Attachment

Susan Wewetzer, Assistant Auditor-Controller, Auditor-Controller Agency, presented the Auditor Controller Procurement Quarterly report.

The information this report is based on payments made to contractors. The summary chart of all payments up to \$500,000 for the period July 1, 2009, through December 31, 2022.

- Total payments up to \$500,000 were \$1.8B
- \$1.1B was paid to local contractors which equals 60.40% of total dollars up to \$500,000
- \$905.8M was paid to MWBE/SLEB contractors which equals 49.12% of total dollars up to \$500,000

All payments to contractors including amounts over \$500,000. This data is presented in the summary on Page A2 for the period July 1, 2009, through December 31, 2022, and includes:

- Total payments were \$4.1B
- \$2.2B was paid to local contractors which equals 54.23% of total dollars
- \$1.5B was paid to MWBE/SLEB contractors which equals 35.72% of total dollars

IV. Update on Disparity Study

Laura Lloyd, County Administrator's Office, gave an oral update on the Disparity Study being conducted by Mason Tillman and Associates.

The industries being studied are construction, architectural and engineering professional services, goods & services, and covers the contracting period of July 1, 2017, through June 30, 2020.

The draft of the Disparity Study was received on November 4, 2022, consisting of over 250 pages, with 11 chapters. In addition, the Board of Supervisors commissioned a workforce utilization study to determine if the ethnicity and gender of workers is in parity with the available workforce. In addition, there has been difficulty in getting the subcontractor information for analysis.

These studies are under review by county staff and the County Counsel's office for edits and comments.

Staff will be coming to the Board for a time-only contract extension of the Disparity Study, as the contract term ended on January 3, 2023.
