I. Presentation on Approved Board Framework and Potential Next Steps Regarding AB 1185 **Sheriff Oversight Implementation** Attachment

Andrea Weddle, Chief Assistant County Counsel, Alameda County Office of County Counsel, Margarita Zamora, Director, Alameda County Human Resource Services Department and Melanie Atendido, Deputy County Administrator, County Administrator's Office presented a PowerPoint presentation on the Approved Board Framework and Potential Next Steps Regarding AB 1185 Sheriff Oversight Implementation.

The presentation outlined the approval process for various recommendations, including:

- Adoption of preliminary directions
- Delegation of authority for recruitment of Project Manager
- Budget establishment and the establishment of employment classifications and salary ranges for the

Sheriff's Oversight implementation and the Office of the Inspector General

The Office County Counsel continues to draft an ordinance for the Sheriff's Oversight implementation and the Human Resources Department will work with the County Administrator's Office in recruitment and classification matters.

The draft ordinance will be presented at the February 2024 Public Protection Committee meeting.

Speakers

Lorelei Bosserman, Louann McKeefery, Michelle, Reverend Jenkins, Sandy Kurtz, Jean Moses, Bob Britton, Wendy Alfsen and Syeda Inamdar commented on the Approved Board Framework and Potential Next Steps Regarding AB 1185 Sheriff Oversight Implementation.

President Miley addressed several points about the Sheriff's Oversight implementation:

He does not support active duty law enforcement being part of the oversight board but is open to retired officers serving after a certain period. He discussed the County Counsel's confidential memorandum and the reasons for not releasing it due to potential precedents and confidential information. In addition, President Miley expressed frustration with the pace of progress but emphasized collaboration and the implementation challenges. He suggested a potential review period after the ordinance is enacted to assess its effectiveness and the possibility of amending it if necessary.
