II. Community Assessment Transport Team Pilot Update Attachment

Stephanie Lewis, Crisis Services Division Director, Alameda County Behavioral Health and Yolanda Takahashi, Emergency Medical Services Coordinator, Alameda County Emergency Medical Services (EMS) presented a PowerPoint presentation on the Community Assessment Transport Team Pilot update.

The Community Assessment Transport Team (CATT), with the assistance of FALCK Emergency Medical Transport and Bonita House, is a clinician focused on community-based crisis intervention and medical clearance. Although clinical staff are 5150/5585 designated, this team focuses on serving consumers who consent to services and transportation to various diversion programs in Alameda County.

CATT is a 5-year pilot program (2018-2020) that pairs a licensed clinician with an EMT. Teams work out of a discretely marked Chevy Tahoe modified to provide basic medical evaluation and client transport. The goal is to eventually have 12 teams covering Oakland, San Leandro, Hayward, and Fremont. Currently CATT has six teams, 7 days a week, from 7:00 am to 11:00 pm. CATT can transport consumers to alternative disposition sites in the community - crisis stabilization, crisis residential, sobering detox, urgent medical clinics and emergency department for medical issues.

III. Update on Alameda County Results First Program Review Attachment

Amy Costa, Deputy County Administrator, Alameda County Administrator's Office, Nancy O'Malley, District Attorney, Alameda County District Attorney's Office, Marcus Dawal, Interim Chief Probation Officer, Alameda County Probation Department, Kevin O'Connell, Project Consultant, California State Association of Counties presented a PowerPoint presentation on the Alameda County Results First Program review.

The Results First Program is a partnership with the California State Association of Counties (CSAC) to evaluate Public Protection programming and support County leaders in instituting evidence- based policy making. The program develops internal County capacity to conduct cost/benefit analysis with respect to the impact of Public Protection programming on recidivism. It also develops internal County capacity to evaluate County data in new ways. To date, the program uses evidence of effectiveness gathered from around the country, and California and has partnerships in 14 California counties.

Next Steps

The Probation Department will take the lead on continuing cross-departmental updates to the Program Inventory. The County will hold quarterly, cross-agency, meetings to discuss updates, utilizing the inventory and other work to discuss 1) program populations, needs, and gaps, 2) evidence-based level of current or proposed programs, 3) future research initiatives and 4) output/outcome goals for current and proposed programs.
