I. Update to the Alameda County Sheriff's Office Military Equipment Inventory List Attachment

Miguel Campos, Captain, Alameda County Sheriff's Office, presented a PowerPoint presentation on the Alameda County Sheriff's Office Military Equipment Inventory list.

Effective January 1, 2022, any proposed or final military equipment use policy shall be made available on the Alameda County Sheriff's Office website for as long as the military equipment is available for use.

The Alameda County Sheriff's Office has commenced a Board approval process for the use of military equipment in accordance with AB 481.

The Sheriff's Office believes the public has a right to participate in the Agency's decision to fund, acquire, or use military equipment. Decisions regarding whether and how military equipment is funded, acquired, or used should strongly consider the public's welfare, safety, civil rights, and civil liberties, and should be based on meaningful public input.

Supervisor Márquez requested that the Sheriff's Office bring this item to the Public Protection Committee on an annual basis in addition, the Supervisor requested the Sheriff's Office return to this Committee with a report on the frequency of the use of scatter shots, munition used inside and outside of Santa Rita Jail over the last two years and alternative methods for maintaining or decreasing the military equipment inventory.

II. Presentation, Discussion and Possible Direction Regarding the Potential Establishment of a County Sheriff's Oversight Board and/or Office of the Inspector General Attachment

Wendy Still, Reimagine Adult Justice Project Manager and Special Advisor to Public Protection Committee, presented a PowerPoint presentation on the Discussion and Possible Direction Regarding the Potential Establishment of a County Sheriff's Oversight Board and/or Office of the Inspector General.

AB 1185 authorizes each of the fifty-eight (58) California counties, either by Board of Supervisor action or vote of county residents to create civilian oversight bodies over their elected sheriffs and to vest them with the power of subpoena.

On May 23, 2023, a presentation was made to the Alameda County Board of Supervisors in which two (2) oversight options were provided for the Board's consideration.

The Board was presented with the following options for establishing Sheriff's Oversight:

Option 1: Establish an Office of the Inspector General and Ombudsman, with the option to add an Oversight Board and Executive Director in Year 2.

Option 2: Establish an oversight structure consisting of an Oversight Board, Executive Director and Office of the Inspector General.

A written report with recommendations will be provided to the Public Protection Committee and the full Board by July 2023. The report will include recommendations related to oversight structure, authority and selection criteria, budget/staffing, and legal counsel options for the oversight system.

Recommendation from the Public Protection Committee: The Public Protection Committee recommends Option 2, to Establish an oversight structure consisting of an Oversight Board, Executive Director and Office of the Inspector General. Additional recommendations:

- 1) The 5 members of the 7 member Oversight Board will be selected by each Board Office and the Board of Supervisors will select two (2) at large members with community input.
- 2) County to explore the idea of a dedicated attorney from the Office of County Counsel
- 3) Office of the Inspector General to be a civilian employee

California Advancing and Innovating Medi-Cal (CalAIM) is a new approach for delivering health care to highly vulnerable, hard-to-serve high utilizing Medi-Cal beneficiaries with complex needs. It includes special focus for justice-involved adults and juveniles, funds Enhanced Care Management and new "Community Supports" benefits and builds on Whole Person Care pilots that emphasize social determinants of health. Medi-Cal managed care plans administer most funding.
