I. Community Corrections Partnership (CCP) Community Advisory Board Update - *continued from June 10, 2021*

Kamarlo Spooner, Chair, Community Advisory Board, presented a PowerPoint presentation on the Community Corrections Partnership (CCP) Community Advisory Board update.

In December 2013, the Alameda County Board of Supervisors established the Community Advisory Board (CAB) to ensure a “community voice” on matters relating to Realignment and reentry in Alameda County. The CAB is a 15-member board, appointed by the Board of Supervisors, with three representatives from each of the five supervisorial districts; at least one of the three members must be formerly incarcerated.

In 2020 and 2021, CCPCAB accomplishments include work on violence prevention/intervention program; housing for women with children; and increasing the CAB membership.

Future goals and priorities include to advocate for change in legislation to include the CAB as a voting member of the CCPEC; data driven decision making to advocate for increased transparency through the sharing of timely data to enable CAB to make better informed decisions; and develop a committee to address the needs of survivors of crime.

II. County Board of Supervisors Sheriff Oversight Board and Office of Inspector General (Assembly Bill 1185) Discussion and Direction

Andrea Weddle, Chief Assistant County Counsel, Alameda County Counsel’s Office presented a PowerPoint presentation on the Sheriff’s Oversight Board and Office of Inspector General (AB 1185) for discussion and direction.

Andres Weddle presented a brief discussion of the Board's authority over the Sheriff; a summary of Assembly Bill 1185; open issues and direction for structure, duties, and role of Sheriff Oversight Board; and open issues and direction for structure, duties, and role of the Office of Inspector General and Inspector General.

AB 1185 adds Section 25303.7 of the Government Code. AB 1185 authorizes the creation, either by Board of Supervisors action or vote of county residents, a sheriff oversight board and/or an office of the inspector general. AB 1185 grants subpoena powers to the chair of the sheriff oversight board and the inspector general.

She reviewed the role of the Oversight Board; the role of the Inspector General; best practices set forth by the National Association of Civilian Oversight of Law Enforcement; mode of creating the Oversight Board; appointment process for the Inspector General; the relationship between the Oversight Board and the Office of Inspector General; and next steps.

Dr. Nicholas Moss, County Health Officer, Public Health Department, Health Care Services Agency
Ronald Browder, Director, Environmental Health Department, Health Care Services Agency presented a PowerPoint presentation on the follow up to the 2020 Annual Jail Inspection report.

Dr. Nicolas Moss presented information on the 2020 Annual Jail Inspection report. County jails and publicly operated detention facilities have annual health and sanitary inspections. Inspections determine if food, clothing and bedding is of sufficient quality and quantity and meet the standards and requirements prescribed by the Board of Corrections. The State provides a medical/mental health evaluation for the inspections. He reviewed the findings for 2015 through 2020.

Ronald Browder reported that food service operations and facilities at Santa Rita Jail are well maintained. Staff and GSA are responsive to recommendations and many issues are abated during the inspection process. There were no major violations. He reviewed the findings and resolutions from 2015 through 2020.
