SUMMARY/ACTION MINUTES

I. Presentation, Discussion, and Direction Regarding the Potential Establishment of a County Sheriff's Oversight Board and/or Office of the Inspector General <u>Attachment</u>

Wendy Still, Special Advisor to Public Protection Committee, Alameda County, presented a PowerPoint presentation, regarding the potential establishment of a County Sheriff's Oversight Board and/or Office of the Inspector General.

The presentation included an update on activities conducted related to the potential establishment of a Sheriff's Oversight Board and/or Office of the Inspector General.

Assembly Bill 1185 Authorizes each of the 58 California counties, either by board of supervisor action or vote of county residents, to create civilian oversight bodies over their elected sheriffs, and to vest them with the power of subpoena.

There has been significant community engagement with stakeholders, including virtual meetings, surveys and focus groups.

Oversight System Model Options

Review-Focused - Often focus on reviewing the quality of completed law enforcement internal affairs investigations; May make recommendations to law enforcement executives on findings or request further investigation; Commonly headed by a review board composed of citizens; May hold public meetings to collect community input and facilitate communication

Investigative-Focused - Routinely conduct independent investigations of complaints against law enforcement; May replace or duplicate the law enforcement's internal affairs process; Staffed by non-law enforcement, "civilian" investigators.

Monitor/Audit-Focused - Often focuses on examining broad patterns in investigations; Some may actively participate in or monitor open investigations; Often seek to promote broad organizational change by conducting systematic reviews of law enforcement policies, practices or training and making recommendations for improvement.

Hybrid - Contain elements from one or more of the three models and are becoming more common Have been developed to address the needs of a specific community and conform to state or local laws May be modifications of a previous oversight agency; May review completed internal affairs investigations. This item was informational only and required no Committee action.

The current circumstances at Alameda County have driven a more profound focus on food service, particularly as is relates to menu satisfaction and sustainable operations. Both of these focus areas are also influenced by the Good Foods Purchasing Program and Aramark's plan reflects a commitment to driving this initiative.

The current cook-chill operation presents many challenges that drive additional cost and waste that can be resolved through a transition to cook-serve operations.

Benefits of Cook-Serve

- Cook-Serve can deliver better, fresher food quality, resulting in more satisfied incarcerated individuals.
- Cook-Serve requires less walk-in storage, freeing up space for more dry storage or other storage needs.
- Cook-Serve drives significant savings from a parts and maintenance, and potential energy savings over time.

As a result, Aramark proposes to align meal costs that reflect the enhancements of the cook-serve operation.
