I. Gender-Based Violence Data, Programs and Services Gaps Update Attachment Item 1

Tunisia M. Owens, Policy and Advocacy Manager, Family Violence Law Center, Nashi Gunasekara, Senior Policy Advocate, Family Violence Law Center and Chantal Hildebrand, Deputy Director at Alliance for Girls, presented a PowerPoint presentation on Gender-Based Violence Data, Programs and Services Gaps.

At current resource and funding levels, the crisis survivors are experiencing is outpacing providers' ability to respond. The pandemic and its socioeconomic repercussions are still deeply affecting communities, especially survivors. Survivors are overwhelmingly women, and women have borne the brunt of the pandemic, the County needs to invest in sustainable pathways to safety and economic security.

The county and community partners are investing in survivor safety and economic security, to interrupt cycles of violence in the community

The victim services and violence prevention providers across Alameda County are requesting a total of \$16 million to:

1. Invest in the need for increased intervention support services such as emergency housing, legal services, and crisis support (\$8 million)

and

2. Invest in critical prevention programming to interrupt cycles of violence in our communities (\$8 million)

II. Reimagining Adult Justice Initiative Update

Attachment Item 2

Wendy Still, Special Advisory to the Public Protection Committee, Alameda County, presented a PowerPoint presentation on Reimagining Adult Justice Initiative Update.

In September 2021, the Board of Supervisors took formal action to reinstate former Chief Probation Officer Wendy Still, Alameda County Probation Department, as the Project Director of the Reimagining Adult Justice (RAJ) initiative.

The objective of RAJ is to, over an 18 to 24 month period, assess and inventory existing in and out of custody justice related programming, identify gaps and opportunities that will reduce our reliance on incarceration, and build on current reforms to further strengthen re-entry systems, reduce recidivism and prevent victimization.

RAJ consists of 12 elements or specifically, 12 questions which will need to be answered to inform Alameda County's reform and integration efforts moving forward.

The Public Protection, Justice & Health Collaborative (PPJHC) was created to develop a Governance Charter Agreement which confirmed a common interest to align, coordinate and leverage systems associated with four service areas/initiatives:

• Health & Homelessness (Health Care Services Agency)

- Care First/Jails Last (Behavioral Health Care Services)
- CalAIM (Alameda Alliance for Health)
- Reimagine Adult Justice (Public Protection)

The County has contracted with Dave Panush, California Health Policy Strategies, LLC for Behavioral Health analysis and Wendy Ware, Consultant for jail data analysis.

Assembly Bill 1185 update

Office of the Inspector General.

• To obtain direction on decision points related to the AB draft ordinance & next steps

AB 1185 authorizes each of the 58 California counties, either by board of supervisor action or vote of county residents, to create civilian oversight bodies over their elected sheriffs, and to vest each or both with the power of subpoena.

The next steps include decisions from the Board of Supervisors regarding the draft ordinance, in addition to revising the draft ordinance in collaboration with County Counsel.

Ms. Still will then provide a full report and presentation to the Public Protection Committee and the Board of Supervisors.
