I. Presentation and Direction Regarding Reimagining Adult Justice Initiative Update Attachment

Wendy Still, Special Advisory to the Public Protection Committee, Alameda County, presented a PowerPoint presentation on the Direction Regarding Reimagining Adult Justice Initiative.

In September 2021, the Board of Supervisors took formal action to reinstate former Chief Probation Officer Wendy Still, Alameda County Probation Department, as the Project Director of the Reimagine Adult Justice (RAJ) initiative.

The objective of RAJ is to, over an 18 to 24 month period, assess and inventory existing in and out of custody justice related programming, identify gaps and opportunities that will reduce our reliance on incarceration, and build on our current reforms to further strengthen re-entry systems, reduce recidivism, and prevent victimization.

RAJ consists of 12 elements or specifically, 12 questions which will need to be answered to inform Alameda County's reform and integration efforts moving forward.


III. Status Report on OC Spray & Physical Restraints: A New Path Forward in Alameda County

IV. Introduction to Assembly Bill 481 – Law Enforcement and State Agencies: Military Equipment: Funding, Acquisition and Use

Richard Lucia, Undersheriff, Alameda County Sheriff's Office and Colby Staysa, Commander, Alameda County Sheriff's Office, presented a PowerPoint presentation on the Introduction to Assembly Bill 481 – Law Enforcement and State Agencies: Military Equipment: Funding, Acquisition and Use.

In accordance with Government Code section 707(a)(1), the Alameda County Sheriffs Office must obtain approval of the Alameda County Board of Supervisors before: 1) Requesting military equipment made available by the Department of Defense; 2) collaborating with other agencies in the use of such equipment; 3) solicit or respond to an agreement to seek funds or apply to receive military equipment.

The Sheriff's Office has submitted a proposed Military Equipment Use Policy and Inventory and documents made available at least 30 days prior to any public hearing. The Sheriff's Office posted their proposed policy on April 4, 2022.

The Sheriff's Office request support from the Public Protection Committee to move this item to the full Board of Supervisors for approval.
