## II. Fatherhood Initiative Update

Kevin Bremond, Alameda County Fathers Corp Administrator, First 5 Alameda County and Ignacio Ferrey, Interim Associate Director, Health Access, Health Care Services Agency/Center for Healthy Schools presented a PowerPoint presentation on the Fathers Corp update.

Alameda County Fathers is a collaborative effort between First 5 Alameda County and Alameda County's Health Care Services Agency and Social Services Agency and was formed in 2013 to support fathers to be meaningfully engaged with their children and to advocate for father-friendly services.

The Fathers Corp work has steadily expanded over the past six years to include a broad approach focused on empowering and supporting fathers, by promoting father-friendly and father-specific programming for families in under-resourced, economically vulnerable neighborhoods and partnering with others to fund and enhance programming.

Service providers who work with Fathers Corp offer learning communities and trainings to enhance provider capacity to engage fathers; by providing safe spaces for learning, peer support, and networking for male providers; and by surveying providers to identify gaps in supports for fathers.

Additional supports for fathers include agencies offer trainings and tools to assist agencies and programs with implementing Father Friendly Principles. Fathers Corp convenes system leaders through an interagency workgroup that seeks to change policies that create barriers to fathers fully engaging with their children.

### III. Child Support Services Update

Phyllis Nance, Director, Department of Child Support Services, presented a PowerPoint presentation on the Alameda County Department of Child Support Services.

The Department of Child Support Services mission is to encourage responsible parenting, family self-sufficiency, and child wellbeing by locating parents, establishing paternity, obtaining and modifying support obligations and collecting support.

In 2020, the Department served over 29,000 families and distributed over \$89 million in child support funds. The Department is responsible for establishing paternity, and collection of current and child support in arrears.

In response to the COVD-19 pandemic, the Department of Child Support Services established contactless checkin, virtual meet-and-confers in addition to launching a new website to better navigate services.
