Summary Minutes

I. Update on General Plan Community Climate Action Plan (CCAP) and Safety Element Attachment

Sophie McGuinness, Senior Planner, Planning Department, Community Development Agency, presented a PowerPoint presentation on the General Plan Community Climate Action Plan (CCAP) and Safety Element.

The Community Climate Action Plan was adopted in 2014, involving multiple agencies/ departments, with extensive community consultation. The CCAP is commits the County to a 2020 GHG Emissions Reduction target.

The Planning Department has released an RFP for a consultant team to support update to the CCAP and the Safety Element, which is required to be updated to include climate adaptation and resilience, (SB379) and will be announcing successful bidder under RFP this week and entering into a contract. The team will work on an update to the CCAP and Safety Element and will begin in March 2022 and be completed by September 2023.

- Matt Turner would like to be included in the report: mode shift, active transportation and transit, rooftop solar challenges, impacts on climate change.
- David Stark, Bay East Association of Realtors, would like to be involved in the climate action plan.
- Bruce King reviewed the previous Climate Action Plan, there was supposed to be a manager, routing meetings and reports. Hoping that the new plan will include a manger of the plan.

II. AB 43 Information and Traffic Safety

Officer Daniel Jacowitz, California Highway Patrol, gave an oral presentation n AB 43 and Traffic Safety.

AB 43 is legislation that would authorize local authorities to consider the safety of vulnerable pedestrian groups, as specified and establish a prima facie speed limit of 25 miles per hour on state highways located in any business or residence district and would authorize the Department of

Transportation (Caltrans) to change the speed limit on any such highway, as prescribed, including erecting signs to give notice thereof.

The California Highway Patrol will continue to conduct speed enforcement in Castro Valley and work with the County roads department (Public Works Agency) for speed enforcement.

III. American Rescue Plan Act (ARPA) Unincorporated Area Funding (\$14,000,000) Grant Attachment Attachment

Eileen Dalton, Director, Economic & Civic Development Department, and Michelle Starratt, Director, Housing & Community Development Department, Community Development Agency, presented a PowerPoint presentation on the American Rescue Plan Act (ARPA) Unincorporated Area Funding Grant.

Pursuant to the Board of Supervisors' direction, the Community Development Agency (CDA) has developed an implementation strategy for the \$14 Million one-time American Rescue Plan Act (ARPA) funding earmarked by the Board of Supervisors for the urban Unincorporated areas.

Below is a list of the programs to be implemented - Unincorporated County Programs \$14,000,000

- Low-cost Financial Services Community Bank RFP \$535,000
- Proactive Rental Inspection and Registry Program \$1,140,000
- Home Repair Program for Rental Units \$2,575,000
- Workforce/Job Training Program \$1,000,000
- Small Business Grants, Façade Improvement, Business Assistance RFP \$2,225,000
- Capital Development (Affordable Housing and Child Care) RFP \$3,000,000
- Community Services RFP \$3,500,000

Implementation of the proposed CDA ARPA Funding Plan entails programs that will provide short-term grant funding, issuance of multiple RFP's, partnerships with other county agencies and a variety of staff driven efforts. CDA will continue to work with the community to prioritize the work so that it can be properly paced according to available staff resources and community need.
