#### 5) **Director's Report**

Director Gwen Hardy arrived at item #5.

Secretary to the Board, April Williamson alerted Directors of National Lead Poisoning Prevention Week and reported back on outreach and education activities noting a twitter chat hosted by the National Center for Healthy Housing and email campaigns for public awareness and education with key messages around food safety, jewelry, rituals, and ceremony powders for the Indian festival season. Department staff is also staffing the Dia de los Muertos event in Oakland on November 3, 2024.

Ms. Williamson informed Directors of an article by El Timpano, "Toxic Inaction: Oakland's lead funding languishes as residents live with serious health risks", a year-long exploration of lead issues impacting immigrant populations in Oakland and referencing the delays in distribution of lead settlement funds by the City. El Timpano will do a follow-up article focusing on health access and treatment to be published in November.

The Department negotiated a one-year contract with the city of Oakland in the amount of \$159,200 for minor home repair services noting an increase in the unit maximum amount to address the need in the community. Ms. Williamson stated the need for minor home repair services in the city is growing and the Department has an 18–24 month waitlist. The contract amount has remained the same over many years.

As part of the Department's fund development activities the Department will submit a U.S. Department of Housing and Urban Development grant application in the amount of \$2 million for an Older Adult Home Modification Program. The Department also submitted a response to a Request for Proposal by Oakland Housing Authority to continue to conduct healthy housing assessments.

Director Noel Gallo asked for clarification about staff negotiating the Oakland minor home repair services contract. Additionally, he informed Directors of the Oakland Unified School District's (OUSD) request for the City to fund \$500,000 in repairs associated with lead in water issues and making note of the restrictions associated with using lead settlement funds.

Director Malia Vella stated she was unaware of specific language limiting lead settlement funding for such repairs and made a recommendation to provide Oakland, Alameda County Board of Supervisors and OUSD with a comprehensive package outlining the history of the lead settlements funds including previous presentations that have come before the JPA Board.

Director John J. Bauters made a recommendation for Oakland to immediately allocate \$500,000 of their portion of lead settlement funds to support OUSD's efforts. Both Directors Vella and Bauters noted that attorneys can provide legal advice and it's at the discretion of the elected body to consider that advice and make an administrative and policy decision.

Director Susan Wengraf reminded Directors that there's a historical precedent from the JPA Lead Board in taking action around OUSD and lead in water issues from 2017. Director Bauters offered to support Director Gallo by going to a Life Enrichment Committee meeting and speaking on the importance for Oakland to allocated funds to address the issue. Director Gallo offered to provide documentation on OUSD's request for funding and dates and times of the next two meetings for the Life Enrichment Committee.

Action: Director Bauters issued a motion for staff to create a memo/ letter that summarizes the history, dollar amounts of lead settlement funds, include a request /recommendation that the city of Oakland can take immediate action to support OUSD and appropriate funds to protect health and safety of children, teachers, parents; and include attachments on past documentation where it has been discussed publicly. The memo/letter to be sent to Oakland City Council and Mayor, and a personal copy to Director Gallo.

Re: Lead Abatement at Oakland Unified School District

Dear Mayor Thao and Members of the Oakland City Council:

On October 24, 2024, the Board of Directors for the Joint Powers Authority that sits as the governing board for the Alameda County Lead Poisoning Prevention Program gave direction to provide the Oakland Mayor's Office and the Oakland City Council with immediate recommendations related to the ongoing situation at Oakland Unified School District with respect to unsafe lead levels at various OUSD sites across the city of Oakland.

In 2000, the City of Oakland and County of Alameda joined other cities and counties across the state as plaintiffs in *County of Santa Clara, et al. v. Atlantic Richfield, et al.* The litigation was brought against a series of paint companies under public nuisance law for marketing and selling lead paint for decades, despite knowing the toxic health impacts of lead and the risks that lead paint posed to human health, and in particular, children.

In July 2019, the parties entered a settlement that provided the plaintiffs with financial damages to address lead hazards in their communities. Approximately \$23.6 million, or 10% of the total settlement, was jointly awarded to the City of Oakland and County of Alameda, with the specific allocation of resources to be decided jointly by the City and County.

Over the following two years, the City and County negotiated the appropriate division of the settlement award. In December 2021, the City and County negotiating teams signed an interim MOU to divide the settlement funds as follows:

- 20% directly to the City of Oakland (\$4,797,184)
- 40% directly to the County of Alameda to benefit non-Oakland residents (\$9,594,369)
- 40% to benefit the City of Oakland, subject to further negotiation (\$9,594,369)

The City of Oakland, as part of the MOU, expressed a desire to develop an Equity-Based Lead Program, derived from a Race and Equity Impact Analysis. Under the MOU, the parties agreed that

after developing the Equity-Based Lead Program, the parties would negotiate the disposition of the remaining 40% of settlement funds for services within Oakland, which may include financing the implementation of an Equity-Based Lead Program, extending enhanced Healthy Homes services provided elsewhere in the County into the City of Oakland, or other lead poisoning prevention programming services. After several years of delays, the City of Oakland recently hired a consultant to begin the work of developing an Equity-Based Lead Program and has indicated to County Healthy Home staff that the process for preparing a proposal may not be ready for another year from now.

In 2017, when lead testing at OUSD found alarmingly high levels of lead at McClymonds High School in West Oakland, our governing board wrote to OUSD and the County Public Health Official about the imminent threat to children in Oakland schools and implored immediate action to protect children from the risks of lead poisoning. The JPA Board is concerned that these risks remain and that all parties need to take immediate action to protect the health and safety of children, teachers, parents, and visitors to Oakland schools.

The JPA Board recommends that the Oakland City Council and Mayor make an immediate appropriation from the settlement funds they have already received to support OUSD in making infrastructure repairs that are necessary to eliminate lead poisoning risks at Oakland schools. We implore the Oakland City Council and Mayor to not delay financial assistance because of their own delays in the development of their planned Equity-Based Lead Program. Our governing board stands united in its desire to protect the health and welfare of OUSD students, teachers and families. Should you desire technical assistance or guidance from Healthy Homes staff, we stand as a ready and willing partner to help bring solutions to this public health crisis.
