# TELECONFERENCING GUIDELINES FOR PUBLIC PARTICIPATION IN THE COUNTY OF ALAMEDA CIVIL SERVICE COMMISSION REMOTE MEETINGS

### **In Person Participation Prohibited**

Due to the public health emergency, the County of Alameda has made several changes related to the Civil Service Commission meetings to protect the public's health and prevent the Coronavirus disease (COVID-19) from spreading. The Civil Service Commission meeting room is closed to members of the public and non-essential County personnel. The Civil Service Commission has made the findings required by the Brown Act, including AB 361, to continue holding meetings by teleconference (remotely).
