In Person Participation Prohibited

Due to the public health emergency, the County of Alameda has made several changes related to the Civil Service Commission meetings to protect the public's health and prevent the Coronavirus disease (COVID-19) from spreading. The Civil Service Commission has made the findings required by the Brown Act, including AB 361, to continue holding meetings by teleconference (remotely).
