### **In Person and Remote Participation**

Members of the public may participate in-person and remotely in County of Alameda Civil Service Commission meetings. ### **Public Comment via Teleconference**

Members of the public may address the Civil Service Commission on a matter that is on the agenda or during the Public Comment portion of the meeting concerning a matter that is not on the agenda but is an issue within the Commission's subject matter jurisdiction.

- If you are calling in, dial \*9 to raise your hand to speak. When you are called to speak, the host will unmute you to enable you to speak.
- If you decide not to speak, you may hang up and dial back into the meeting or simply notify the Conference Host that you do not wish to speak when you are unmuted and asked to speak.
