Public Comment via Teleconference

- If you are calling in, dial *9 to raise your hand to speak. When you are called to speak, the host will unmute you to enable you to speak.
- If you decide not to speak, you may hang up and dial back into the meeting or simply notify the Conference Host that you do not wish to speak when you are unmuted and asked to speak.
