**Subject: APPROVE ONE-TIME ALLOCATION OF MEASURE A FUND IN THE AMOUNT OF \$20,000; APPROVE A MASTER CONTRACT AMENDMENT WITH SOUTHERN ALAMEDA COUNTY COMITE FOR RAZA MENTAL HEALTH DBA LA FAMILIA COUNSELING SERVICE FOR YOUTH AND FAMILY OPPORTUNITY PROGRAM SERVICES IN HAYWARD/EDEN AREA AND UNACCOMPANIED IMMIGRANT YOUTH (UIY) PROGRAM SERVICES IN THE TRI-CITIES REGION**

**RECOMMENDATIONS:**

- A. Approve a one-time allocation of Measure A fund in the amount of \$20,000 to provide behavioral health services to youth and families at the Glad Tiding Church Campus in Hayward/Eden area.
- B. Approve a new Procurement Contract No.13916 under Master Contract No. 900135 with Southern Alameda County Comite for Raza Mental Health DBA La Familia Counseling Service (Principal: Belinda Hernandez; Location: Hayward) to provide the Youth and Family Opportunity Program services to students and families in Hayward/Eden Area and the Unaccompanied Immigrant Youth (UIY) Program services in the Tri-Cities region, for the period of July 1, 2016 through June 30, 2017, in the amount of \$425,644; and
- C. Authorize the Acting Director, Health Care Services Agency, to execute the Master Contract Amendment and send it to the Clerk of the Board for filing

**DISCUSSION/SUMMARY:**

On December 8, 2015, your Board approved a three-year Measure A base allocation in the amount of \$2,597,818 each year for the Youth and Family Opportunity (YFO) Initiative and \$164,902 base allocation for the Unaccompanied Immigrant Youth (UIY) Program.

The Youth and Family Opportunity Program of Health Care Services Agency's Center for Healthy Schools and Communities continues to strengthen the capacity of "anchor" community-based

organizations to provide a continuum of integrated, high quality, and accessible school-linked health and wellness supports to youth and families, with a focus on low-income, and uninsured children and their families. The YFO Program works through the provider network to strengthen place-based community hubs in each of the county's five major geographic regions.

Approval of this contract amendment would allow the contractor to provide health and wellness services that include case management, family engagement, health and benefit assessment and referrals, health enrollment and capacity-building workshops for adults and caregivers through following three programs:

- **Parent Ambassador Program** in Hayward Unified School District (HUSD): The contractor would facilitate and coordinate training for 30 Parent Ambassadors to support parent engagement activities, utilizing the Promotora curriculum with HUSD specific topics such as leadership, outreach, youth development and family strengthening with focus on health access.
- **Glad Tiding Church Campus** in the Hayward/Eden Area: The contractor would provide uninterrupted short-term, solution-oriented behavioral health treatment to 300 clients at the Glad Tiding Church campus during Fiscal Year 2016-2017. The services include intake, assessment, treatment planning, treatment, consultation and referral to health and social services.
- **The Unaccompanied Immigrant Youth (UIY) Program** in the Tri-Cities area: Using a resilience-focused approach, the contractor will conduct outreach to UIY and their caregivers, determine student and family service needs, and coordinate the delivery of services to UIY and their caregivers residing in Fremont, Newark and Union City. The contractor will also collaborate with caregivers, community service providers, school administrators and teachers to identify strategies for meeting the health, social-emotional, and educational needs of UIY.

On 12/8/2015, your Board approved an allocation of \$150,000 per Supervisor for the Board district health care services discretionary account to address the myriad of critical health needs that require immediate attention during the course of each fiscal year. Board of Supervisors District 2 will utilize \$30,000 of its Measure A health care discretionary fund to support the Glad Tiding Church Campus.

#### **SELECTION CRITERIA**

*La Familia Counseling Service was selected to receive Youth and Family Opportunity Measure A funding through a public hearing process held on 1/24/2011 in the Board of Supervisors' Board Chambers at 1221 Oak St., Oakland, CA 94612. The selection process included reviewing a recommendation for funding allocation submitted by Health Care Services Agency, a public hearing on 1/24/11, and Board approval on 4/12/2011. Measure A funding allocation and providers that included La Familia were approved by the Board of Supervisors on April 12, 2011, reauthorized on November 6, 2012 and December 8, 2015.*

*La Familia Counseling Services was selected to be the Case Manager/Lead Agency for the Unaccompanied Immigrant Youth (UIY) Program in Tri-Cities through a competitive procurement process administered by Health Care Services Agency in March of 2016. Three proposals were received and La Familia Counseling Services received the highest score for their proposal.*

*La Familia Counseling Service is a community-based organization that provides direct services to Alameda County residents and is exempt from the SLEB program requirements.*

**FINANCING:**

Financing for the contract amendment (\$425,644) is provided by Measure A funds and MHSA Grant. \$160,742 of the contract total amount is provided with YFO Measure A fund approved by your Board for services in Hayward and is included in the Fiscal Year 2016-2017 Budget. \$20,000 comes from one-time Measure A allocation. \$30,000 is funded with Board of Supervisor District 2 Discretionary Health Care Services Measure A fund. \$50,000 will be provided with the Mental Health Services Act (MHSA) grant by Behavioral Health Care Services.

The remaining \$164,902 comes from Measure A base allocation for the UIY Program approved by your Board on 12/8/2015.

The \$20,000 one-time Measure A fund comes from the Measure A reserve, which includes revenue received that exceeds the Fiscal Year 2016-2017 Budget. Approval of this amendment will bring the total amount of Measure A one-time expenditures that exceed the Fiscal Year 2016-2017 Budget to \$414,921. Approval of the recommendations will have no impact on Net County Costs.
