SUBJECT: AWARD A CONTRACT TO BENJAMIN BYUNG YUH DBA NICHOLS HILL

PRESCRIPTION PHARMACY FOR PHARMACEUTICAL SUPPLIES AND SERVICES:

MASTER CONTRACT NO. 901746; AMOUNT: \$216,000

#### RECOMMENDATION:

Authorize the Purchasing Agent to execute a contract (Master Contract No. 901746; Procurement Contract No. 18323) with Benjamin Byung Yuh dba Nichols Hill Prescription Pharmacy (Principal: Benjamin Yuh; Location: Oakland) to provide pharmaceutical supplies and services to the Alameda County Health Care Services Agency – Public Health Department, for the term of 7/1/19 – 6/30/22, in the amount of \$216,000.

## DISCUSSION/SUMMARY:

Alameda County Tuberculosis (TB) Control and Acute Communicable Disease (CD) Control are statemandated programs whose goals are to prevent the spread of TB and other CDs in the community and to preserve the public health of Alameda County. TB and Acute CD Controls are separate sections within the Division of Communicable Disease Control and Prevention (DCDCP).

The priorities and objectives of DCDCP TB and Acute CD Controls are to ensure early identification and reporting of all persons with TB and Acute CD; to ensure timely completion of appropriate therapy; and to ensure contacts to persons with communicable disease are promptly identified, examined, and, as applicable, treated.

Pharmacy services are needed for clients for whom cost presents a barrier (due to lack of insurance, inadequate insurance coverage, or high copays) to procuring their prescribed medication. This barrier may result in delays in initiation and completion of treatment, subsequent worsening of clients' disease, prolonged infectious periods, and increased risk of transmission to members of the public.

### SELECTION CRITERIA/PROCESS:

The Health Care Services Agency (HCSA) – Public Health Department (PHD) has determined that Alameda County does not currently have the resources to provide pharmaceutical supplies and services.

HCSA-PHD worked with General Services Agency-Procurement to develop a Request for Proposal (RFP) which was issued on March 1, 2019, posted on the website for 48 days, and sent to the subscribers to the E-Gov Goods and Services — Current Contract Opportunities mailing service. Two networking/bidders conferences were held and were attended by zero vendors.

On April 18, 2019, two responses to the RFP were received. Springwell Pharmacy's (Oakland, CA) bid response was disqualified due to not meeting the Small Local and Emerging Locally Owned Business requirements at the time of bid response submission. The remaining response was evaluated by the PHD. The RFP states that if only one qualified bid response is received, Alameda County has the right to waive the County Selection Committee evaluation process and move straight to contract negotiations.

Benjamin Byung Yuh dba Nichols Hill Prescription Pharmacy (Principal: Benjamin Yuh; Location: Oakland; Certified Small: 06-90903; Expiration: November 30, 2020) was the sole qualified vendor and is being recommended for award. The following is the evaluation summary:
