SUBJECT: Approve the Recommended Awards from the Alameda County Area Agency on

Aging Request for Proposals

RECOMMENDATION:

It is recommended that your Board:

- A. Approve the recommended awards from the Alameda County Area Agency on Aging's Requests for Proposal (RFP) procurements for Nutrition, Family Caregiver, Supportive, Senior Employment, Senior Injury Prevention Program, and Health Insurance & Counseling services, for seniors, for the award period of July 1, 2014 through June 30, 2018, totaling \$5,578,683 for FY 2014-2015 as detailed by Attachment A and the two contracts listed below. All contracts awarded under these RFP's for the first year (July 1, 2014 through June 30, 2015) are subject to annual renewal for three additional one-year periods based on satisfactory performance, contract compliance, and available funding.
- B. Delegate authority to the Social Services Agency Director, or designee, to execute amendments to the contracts listed in Attachment A;
- C. Approve a new Standard Services Agreement, (PC No.10331) with Nutrition Solutions (Principal: Jan Speers, Oakland) in the amount of \$388,079 for FY 2014-2015, for Nutrition Services and delegate authority to the Social Services Director, or designee, to execute the new Agreement.
- D. Approve a new CBO Master Contract Agreement, (PC No.10334), with On Lok Health Services (Principal: Elenda Nikklason, Fremont) in the amount of \$25,795 for FY 2014-2015 for Supportive Services and delegate authority to the Social Services Director, or designee, to execute the new Agreement.

DISCUSSION/SUMMARY:

On an annual basis, the Alameda County Area Agency on Aging (AAA) provides services to more than 56,000 seniors. The AAA, mandated by the Older American's Act, has responsibility for conducting a Needs Assessments of seniors and a resulting Area Plan, both of which inform the selection and provision of services for seniors. The AAA manages two direct service programs, Information & Assistance and the Long-Term Care Ombudsman program, and contracts with other organizations to provide services for seniors throughout the County. These contracted services reflect the priorities identified in the Area Plan and include nutrition, family caregiver, supportive, senior employment, senior injury prevention, and Health Insurance & Counseling Program services.

The funding recommendations attached include a broad spectrum of services for low-income seniors including but not limited to meals, case management services, disease prevention services, and information and assistance for monolingual populations.

SELECTION CRITERIA/PROCESS:

Under guidelines established by your Board, the Older Americans Act, and the California Code of Regulations, Area Agencies on Aging are required to release a RFP at least once every four years to assure fair and open competition for all services under these acts. The AAA's RFP process was developed to comply with Federal and State regulations, to be without bias, and to withstand appeals in regard to the fairness of the proceedings.

In January 2014, the AAA worked in partnership with the General Services Agency to publish the six separate RFP's for: Nutrition Services, Supportive Services, Family Caregiver Support Services, Senior Injury Prevention Program, Senior Employment Community Service Program, and Health Insurance Counseling & Assistance program. GSA published the RFP's on the County Website, and the AAA distributed notice of the RFP's through its email list, which includes more than 1,000 people. The RFP included minimum service standards, reimbursement rates for service units, and detailed service unit descriptions, consistent with state and federal requirements for service delivery for each program.

The AAA conducted at least one Bidder's Conference for every RFP. All questions and answers from the Bidder's Conference were posted on the GSA website. As outlined in the RFP, agencies were evaluated on the following: 1) Mission, Experience and Community Involvement, 2) Program Delivery, and 3) Administrative and Fiscal Qualifications. Evaluation of agencies included their ability to meet targeting standards to serve low-income and minority populations in your communities. Eighty-six applicants submitted requests totaling \$7,272,591 in funds. One application was not submitted by the published deadline. The remaining applications were reviewed and scored by panelists using criteria established in the RFP. Sixty-one of the applicants received recommendations for funding totaling \$5,578,683. Recommendations for funding were based on the availability of funds as determined by the intra-county funding formula approved by your Board for services, with prioritization of services for low-income and ethnic minority populations, and ranking within program categories.

The AAA received the following SLEB waivers for contracts receiving federal funds: Nutrition Services (F607-\$3,181,247), Supportive Services (F604 - \$1,241,111), Family Caregiver Support Program (F606 - \$516,513), Senior Community Employment Program (F608 - \$145,819), Health Insurance Counseling Assistance Program (F605-\$393,995).

FINANCING:

Financing for services resulting from the RFP will come from Federal and State funds awarded to Alameda County by the California Department of Aging and from County Funds. All funding is included in the Social Services budget for FY 2014-2015 and will be included in future SSA budgets. There is no change to net County cost as a result of approval of the Area on Aging RFP contract award recommendations.
