## RESOLUTION SUPPORTING ALAMEDA COUNTY WATER CONSERVATION MEASURES THE BOARD OF SUPERVISORS OF THE COUNTY OF ALAMEDA, STATE OF CALIFORNIA

WHEREAS, on January 15, 2014, the Secretary of the United States Department of Agriculture designated 27 California counties, [including Alameda, Alpine, Amador, Calaveras, Contra Costa, El Dorado, Fresno, Inyo, Kings, Kern, Los Angeles, Madera, Mariposa, Merced, Mono, Monterey, Sacramento, San Benito, San Bernardino, San Joaquin, San Luis Obispo, Santa Clara, Santa Barbara, Stanislaus, Tulare, Tuolumne, and Ventura] as natural disaster areas due to drought which makes farm operators in the designated counties eligible to be considered for certain assistance including emergency loans from the U.S. Farm Service Agency for production losses; and

**WHEREAS**, on January 17, 2014, the Governor of the State of California proclaimed a state of emergency in the California due to record dry conditions that have persisted since 2012; and

**WHEREAS**, there is worldwide consensus among scientists that climate change will continue to cause disruption of historical weather patterns and that warmer temperatures will further exacerbate drought impacts on our communities and the environment; and

**WHEREAS**, the Alameda County Board of Supervisors has made strong commitments to take bold climate action to mitigate and plan for the impacts of climate change such as drought; and

**WHEREAS**, the ongoing drought has resulted in loss of ground water thereby causing extreme economic hardship to residents and agricultural businesses who have incurred high costs as a result of the need to deepen or replace wells in Alameda County; and

**WHEREAS**, access to safe and affordable clean water is essential for public health and well being; and

**WHEREAS**, persistent drought conditions have negatively impacted and continue to threaten the safety of persons, property, agriculture and recreation activities, and have compounded already perilous fire conditions threatening cities and communities in Alameda County; and

**WHEREAS, on April 1, 2015** the Governor of the State of California issued Executive Order B-29-15 which among other actions directed the State Water Resources Board to impose various restrictions to achieve a statewide 25% reduction in potable urban water use; and

## NOW, THEREFORE,

**BE IT RESOLVED** that the Board of Supervisors of the County of Alameda urges all residents and businesses of Alameda County to do their part in conserving and reducing their water usage; and

**BE IT FURTHER RESOLVED** that the Board of Supervisors of the County of Alameda directs all County agencies and employees to reduce their water use, and directs the General Services and the Public Works Agencies to establish water usage baselines for County facilities and services, develop water conservation implementation plans, and to measure and report progress; and

**BE IT FURTHER RESOLVED** that the Board of Supervisors of the County of Alameda for reasons set forth herein, urges water suppliers in Alameda County to heed the Governor's Drought Executive Order by encouraging their customers to reduce water usage by at least 25%, and implement water shortage contingency plans; and

**BE IT FURTHER RESOLVED** that federal and state agencies are requested to provide financial and other assistance to residents, water suppliers, water rights holders, ranchers, farmers, business owners and local governments in Alameda County to help them mitigate the persistent drought conditions.
